Foreclosure Statistics (FS)

Fourth quarter of 2019 and year 2019. Provisional data

Registration of foreclosure certifications initiated on main dwellings have decreased by 12.3%

60.5% of foreclosures initiated on dwellings correspond to mortgages constituted between 2005 and 2008

In 2019 as a whole, foreclosures initiated on permanent dwellings were down by 21.8%

The total number of registrations of certifications of foreclosures initiated in the land registers in the fourth quarter of 2019 was 12,882, which means 4.1% less than in the previous quarter and 19.1% more than in the same quarter of 2018.

Among the dwellings of natural persons with foreclosure, 1,380 were the main dwellings of their owners (12.3% less than in the same quarter of 2018) and 453 were not (23.9% less).

Certifications of foreclosures initiated and registered according to the type of property


Foreclosures on dwellings accounted for 46.7% of the total foreclosures during the fourth quarter of 2019.

10.7% of the total number of foreclosures were on main dwellings of natural persons. 32.5% corresponds to the dwellings of legal entities and the remaining 3.5% to other dwellings of natural persons.

On the other hand, foreclosures of other urban properties (business premises, garages, offices, storage rooms, warehouses, buildings intended for housing and other buildings and urban developments) accounted for 42.1% of the total.

Certifications of foreclosures initiated and registered on dwellings according to status

17.9% of foreclosures during the fourth quarter were on new dwellings and 82.1% were on used dwellings.

The number of foreclosures on new dwellings decreased by 26.8% in the annual rate and that of used dwellings by 15.2%.


Certifications of foreclosures on dwellings according to the year of registration of the mortgage

25.0% of foreclosures initiated on dwellings in the fourth quarter corresponded to mortgages constituted in the year 2007, 14.4% to mortgages constituted in 2008 and 13.7% to mortgages constituted in 2006.

The 2005-2008 period accounted for 60.5% of foreclosures initiated in this quarter.

Results by Autonomous Community

In the fourth quarter, the Autonomous Communities with the greatest number of certifications of foreclosures on the total properties were Comunitat Valenciana (2,785), Andalucía (2,606) and Cataluña (2,454). In turn, Comunidad Foral de Navarra (18), País Vasco (67) and Cantabria (107) registered the smallest number of foreclosures.

In the case of dwellings, Andalucía (1,339), Comunitat Valenciana (1,278) and Cataluña (1,123) registered the greatest number of foreclosures. And Comunidad Floral de Navarra (nine), País Vasco (20) and Cantabria (52) had the lowest number.

Results for the whole of the year 2019

The total number of registrations of certifications for foreclosures initiated in 2019 was 56,349, which means 2.9% more than in 2018.

Of the 76.2% of the dwellings of natural persons with foreclosures, 5,177 were owned permanent dwellings, (21.8% less than in 2018). Meanwhile, 1,952 were the non-permanent dwellings of their owners (19.5% less).

Certifications of foreclosures initiated and registered on dwellings according to status

23.4% of foreclosures on dwellings in the year 2019 were new and 76.6% were used.

The number of foreclosures on new dwellings increased by 19.3% compared to the previous year, while that of used dwellings dropped by 1.0%.


Certifications of foreclosures on dwellings according to the year of registration of the mortgage

In 2019, 23.9% of foreclosures initiated on dwellings corresponded to mortgages constituted in the year 2007, 16.2% to mortgages constituted in 2008 and 13.3% to mortgages constituted in 2006.

The 2005-2008 period accounted for 60.3% of the foreclosures initiated in 2019.

Results by Autonomous Community

In 2019, the Autonomous Communities with the greatest number of foreclosures certifications on the total properties were Cataluña (12,131), Comunitat Valenciana (11,644) and Andalucia (9,834). In turn, Comunidad Foral de Navarra (174), País Vasco (218) and La Rioja (495) registered the lowest number.

Cataluña (5,757), Andalucía (5,681) and Comunitat Valenciana (5,356) registered the greatest number of dwelling foreclosures. The autonomous communities with the lowest number were Comunidad Foral de Navarra (54), País Vasco (81) and La Rioja (143).

Revision and updating of data

The data published today are provisional and will be reviewed in the fourth quarter of this year.

Methodological note

The Foreclosure statistics provide information on foreclosure certifications initiated and registered in the Land Registers during the reference quarter, relating to all rural and urban properties. The results are broken down on the basis of various variables such as the nature of the property, regime, state and owner of the dwellings with a foreclosure initiated.

The information on foreclosure certifications is obtained from the data contained in the Land Registries of the entire national territory. The Association of Land and Mercantile Registrars of Spain (CORPME) provides centralised information to the INE.

Type of survey: quarterly continuous survey.

Population scope: registration of foreclosure certifications that are initiated and registered in the land registries.

Geographical scope: the entire national territory and Autonomous Communities.

Reference period of the results: the calendar quarter.

Reference period of the information: the calendar quarter.

Classification: rural and urban properties (dwellings, plots and other urban properties). Dwellings of natural and legal persons, main dwelling and other dwellings.

Collection method: administrative registers from the Association of Land and Mercantile Registrars of Spain.
