### Foreclosure Statistics (FS)

Fourth quarter of 2021 and year 2021. Provisional data

## Enrolments for foreclosures initiated on the homes of individuals increased by 5.4% in the annual rate

Those initiated on the dwellings of legal persons fell by 44.4%

## In 2021 as a whole, foreclosures initiated on permanent dwellings of natural persons rose by 53.3%

The total number of registrations of certifications of foreclosures initiated in the land registers in the fourth quarter of 2021 was 7,866, which means 20.9% less than in the previous quarter and 22.7% more than in the same quarter of 2020.

Among the dwellings of natural persons with foreclosure, 3,231<sup>1</sup> were the main dwellings of their owners (4.8% more than in the same quarter of 2020) and 818 were not (7.9% more).

It should be noted that not all foreclosures that are initiated end with the eviction of their owners and that legal proceedings can lead to several certifications of foreclosures.

## Certifications of foreclosures initiated and registered according to the type of property

Foreclosures on dwellings accounted for 64.9% of the total foreclosures during the fourth quarter of 2021.


34.8% of the total number of foreclosures were on main dwellings of natural persons. They totalled 3,231, or 4.8% more than in the fourth quarter of 2020.

13.4% corresponds to the dwellings of legal entities and 10.4% to other dwellings of natural persons. In the first case there were 1,057 executions (44.4% less in the annual rate) and in the second there were 818, 7.9% more.

On the other hand, foreclosures of other urban properties (business premises, garages, offices, storage rooms, warehouses, buildings intended for housing and other buildings and urban developments) accounted for 27.8% of the total.

## Certifications of foreclosures initiated and registered on dwellings according to status

11.0% of foreclosures during the fourth quarter were on new dwellings and 89.0% were on used dwellings.

The number of foreclosures on new dwellings decreased by 24.3% in the annual rate and that of used dwellings by 9.1%.


## Certifications of foreclosures on dwellings according to the year of registration of the mortgage

A total 18.9% of foreclosures initiated on dwellings in the fourth quarter corresponded to mortgages constituted in the year 2007, 15.6% did so to mortgages constituted in 2006 and 10.1% to mortgages constituted in 2008.

The 2005-2008 period accounted for 54.0% of foreclosures initiated in this quarter.

### **Results by Autonomous Community**

In the fourth quarter, the Autonomous Communities with the greatest number of certifications of foreclosures on the total properties were Comunitat Valenciana (1,960), Andalucía (1,743) and Cataluña (1,141). In turn, Comunidad Foral de Navarra (35), La Rioja (38) and Cantabria (84) registered the lowest number.

In the case of dwellings, Andalucía (1,173), Comunitat Valenciana (1,130) and Cataluña (849) registered the greatest number of foreclosures. The lowest numbers were in the Autonomous Community of Navarra (23), La Rioja (25) and Illes Balears (41).

### Results for the whole of year 2021

The total number of registrations of certifications for foreclosures initiated in 2021 was 32,383, which means 7.4% less than in 2020.

Of the 14,862 dwellings of natural persons with foreclosures, 11,947 were owned permanent dwellings (57.4% less than in 2020). Meanwhile, 2,915 were the non-permanent dwellings of their owners (38.6% more).

### Certifications of foreclosures initiated and registered on dwellings according to status

11.1% of foreclosures on dwellings in the year 2021 were on new dwellings and 88.9% were on used dwellings.

The number of foreclosures on new dwellings decreased by 27.8% compared to the previous year, while that of used dwellings rose by 13.6%.


## Certifications of foreclosures on dwellings according to the year of registration of the mortgage

In 2021, 17.6% of foreclosures initiated on dwellings corresponded to mortgages constituted in the year 2007, 14.0% to mortgages constituted in 2006 and 9.9% to mortgages constituted in 2005.

The 2005-2008 period accounted for 51.1% of the foreclosures initiated in 2021.

### **Results by Autonomous Communities**

In the third quarter, the Autonomous Communities with the greatest number of certifications of foreclosures on the total properties in 2021 were Comunitat Valenciana (7,573), Andalucía (6,727) and Cataluña (5,287). In turn, Comunidad Foral de Navarra (136), La Rioja (266) and Extremadura (273) registered the lowest number.

Andalucía (4,510), Comunitat Valenciana (4,402) and Cataluña (3,703) registered the greatest number of housing foreclosures in the year 2021. The autonomous communities with the lowest number were Comunidad Foral de Navarra (86), La Rioja (133) and Cantabria (164).

#### Revision and updating of data

The 2021 data is provisional and will be reviewed in this year's third quarter.

### Methodological note

The Foreclosure statistics provide information on foreclosure certifications initiated and registered in the Land Registers during the reference quarter, relating to all rural and urban properties. The results are broken down on the basis of various variables such as the nature of the property, regime, state and owner of the dwellings with a foreclosure initiated.

The information on foreclosure certifications is obtained from the data contained in the Land Registries of the entire national territory. The Association of Land and Mercantile Registrars of Spain (CORPME) provides centralised information to the INE.

Type of survey: quarterly continuous survey.

**Population scope**: registration of foreclosure certifications that are initiated and registered in the land registries.

**Geographical scope**: the entire national territory and Autonomous Communities.

Reference period of the results: the calendar quarter.

**Reference period of the information**: the calendar quarter.

**Classification**: rural and urban properties (dwellings, plots and other urban) Dwellings of natural and legal persons, main dwelling and other dwellings.

**Collection method**: administrative registers from the Association of Land and Mercantile Registrars of Spain.
