


Statistics on Transfer of Property Rights
September 2012. Provisional data

In September, the number of property transfers is 121,822, 1.4% less than the same month the previous year

25,985 merchanting of dwellings are registered, with an annual increase of 0.9%

The number of property transfers **recorded in the land registries, from public deeds previously registered**, was 121,822 in September, that is, 1.4% less than for the same month in 2011, and 5.7% lower than in August 2012.

In the case of registered merchantings of property, the number of transfers was 55,930, representing an annual increase of 0.7%, and a decrease of 7.8%, as compared with the previous month.

* "Other tittles" includes land consolidation, horizontal divisions, joint ventures or mixtures of several titles transmission, transmissions without title of acquisition, Nonrecourse debt, foreclosures and court awards.

Merchantings recorded in the land registries

85.2% of the registered merchantings in September corresponded to urban properties and 14.8% to rustic properties. Among the urban properties, 54.5% were merchantings of dwellings.

The number of merchantings of rustic properties decreased 1.4% in the annual rate in September, and that of urban properties increased 1.0%. Within the latter, merchantings of dwellings increased 0.9%.

Registered merchantings of dwellings, by protection system and status


87.2% of transfers of dwellings by merchanting in September were free housing, and 12.8% were protected housing. In annual terms, the number of transfers of free dwellings by merchanting increased 2.9%, while that of protected housing decreased 10.8%.

49.1% of the dwellings transferred by merchanting in September were new, and 50.9% were used. The number of transactions on new dwellings increased 1.8%, as compared with September 2011. The number of used dwellings remained the same.

Geographical distribution

In September 2012, the total number of property transfers recorded in the land registries per 100,000 inhabitants¹ was highest in the Autonomous Communities of Castilla y León (563) and Castilla-La Mancha (526). In turn, the Autonomous Communities showing the highest interannual variation rate were La Rioja (34.6%) and Región de Murcia (24.7%), while those showing the highest decrease were Canarias (-19.0%) and Aragón (-15.6%).

By registered merchantings of dwellings, the Autonomous Communities in which the number of transfers per 100,000 inhabitants¹ was highest were La Rioja (128) and Comunitat Valenciana (103). In turn, the Autonomous Communities showing the highest interannual variation rate were La Rioja (94.1%) and Región de Murcia (29.7%), while those showing the highest decrease were Comunidad Foral de Navarra (-40.6%) and Extremadura (-35.4%).
