Services Sector Activity Indicators. Base 2005 March 2007. Provisional data

The Services sector turnover grew by 7.7% during March, as compared with the same month in 2006

The interannual rate of employed persons increases 3.1%

The Services sector turnover grew by 7.7% during March, as compared with the same month in 2006.

All sectors contributed to this growth. Services Rendered to Companies is the sector experiencing a higher growth, with interannual rate of 11.9%. They are followed by Tourism Activities (9.7%), the Information and Communications Technologies (7.6%), Trade (7.2%) and Transport (7%) sectors.

In the field of Services Rendered to Companies, the most dynamic activities are Advertising (15%) and Technical Services (14.2%). Among the remaining activities, it is worth noting the interannual turnover growth rate yielded by Travel Agencies (15.9%), partly due to the fact that last year Holy Week celebrations took place in mid-April, while this year they did at the beginning of said month.



Comunidad Foral de Navarra and Galicia registered the highest interannual turnover growth rates

Comunidad Foral de Navarra was the Autonomous Community which registered the highest turnover growth rates in March, with a 12.3% rate. It is followed by Galicia, with a 10.9% rate.

On the opposite side, the lowest turnover growth rates were registered in La Rioja (4.5%) and Cantabria (5.3%).



The interannual employment rate increased 3.1%

The interannual employment rate for the Services Sector increased by 3.1% All sectors contribute to this growth. For another month, Services Rendered to Companies and Information and Communication Technologies were the sectors contributing the most to employment creation, with interannual growth rates of 5.5% and 3.3%, respectively.

Employed personnel growth rates stood at 2.8% for the Transport sector, 2.3% for Trade and 1.7% for Tourism Activities.

Regarding the Services Rendered to Companies sector, it is worth noting the interannual growth rate in Labour Recruitment and Provision of Personnel, 10.5%, followed by Investigation and Security, and Advertising activities, with 6.3% and 6.2% rates, respectively.

The greatest increases in employed personnel were measured in Illes Balears and Castilla y León.

Illes Balears was the Autonomous Community which registered the greatest growth in occupied personnel in the Services Sector during March, with an interannual rate of 4.8%. Castilla y León follows, with a 4.2% interannual increase.

On the other hand, the lowest growth rates were registered in Extremadura (1%) and Canarias (1,2%).
