Turnover in the¹ Market Services Sector stands at 4.1%, after adjusting for seasonal and calendar effects


The annual rate stands at −10.0% in the series adjusted for seasonal and calendar effects and at −8.7% in the original series

Throughout the year 2020, turnover decreased by 15.6% in both the adjusted series and the original series

Monthly trend in turnover for the Market Services Sector

After adjusting for seasonal and calendar effects, the monthly variation of the general index of turnover for the Market Services Sector between December and November was 4.1%. This rate is 5.5 points higher than that observed in November.

General index of the turnover for the Market Services Sector Seasonally and calendar adjusted. Monthly rate. Percentage




¹ As reflected in the methodology of this value index, the information is presented in current (nominal) terms, without adjusting the effects in the price variation.

After adjusting for seasonal and calendar effects, *Trade* increased by 4.1% and *Other services* by 3.7%.

Seven of the eight sectors registered positive monthly rates, noteworthy being the increase in *Accommodation* (17.9%) followed by *Administrative and support service activities* (6.0%). The only sector that decreased was *Information and communications* (-1.0%).




Annual trend in the turnover indices for the Market Services Sector

The general index of the turnover for the Market Services Sector, after adjusting for seasonal and calendar effects, experienced a variation of −10.0% in December compared to the same month of 2019. This rate is 3.2 points higher than that recorded in November.

The original series presented an annual variation of -8.7%, which is almost four points above that registered in November.

After adjusting for seasonal and calendar effects, *Trade* decreased by 6.8% as compared with December 2019 and *Other services* by 15.9%.

By sectors, Retail trade (-1.0%), Professional, scientific and technical activities (-2.5%) and Information and communications (-6.5%) registered the largest increases. In turn, Accommodation (-52.7%) and Administrative and support service activities (-24.9%) recorded the largest decreases.

Throughout the year 2020, turnover for the Market Services Sector decreased by 15.6% in both the adjusted series and the original series.

Annual evolution by sectors


In 2020, the situation caused by COVID-19 resulted in significant changes in the evolution of the different indicator sectors, as compared to previous periods. This evolution was slightly different between the sectors, and different in the different periods of the year.

In the months from March to June, when the state of alarm was decreed for the first time, non-essential retail establishments and stores, as well as hotel and restaurant activities, were suspended for the public. There was an almost total stoppage of the Services Sector. While this affected all sectors, it had a particularly significant influence on *Hospitality*. On the other hand, *Information and communications* was the least affected; it had a smaller decrease in this period.

With de-escalation and the arrival of the "new normality," a generalized recovery took place. This continued for most sectors during the second half of the year. However, this recovery has not been the same across sectors: in *Hospitality* growth slowed down after the summer, once more declining.

In 2020 as a whole, all sectors presented negative annual rates. *Information and communication (-8.8%)* and *Scientific and technical activities* (-10.6%) registered the lowest decreases. On the other hand, Hospitality (-50.1%) and Administrative and support service activities (-29.6%) presented the largest decreases.

Annual rates by sectors. Base 2015=100 Adjusted for seasonal and calendar effects




Results by Autonomous Communities. Annual variation rates of turnover. Original series

Annual rate in Turnover index for the Market Services Sector decreased as compared to December 2019 in all the Autonomous Communities. In all Autonomous Communities, Market Services Sector turnover decreased compared to December 2019.

Canarias (-27.0%), Illes Balears (-23.8%) and Comunidad de Madrid (-11.8%) recorded the largest decreases.

In the year 2020 as a whole, all communities showed negative rates. Illes Balears registered the greatest decrease (-37,8%).

Employment trend

Employment in the Market Services Sector experienced a variation of -4.9% in December as compared to the same month of the previous year. This rate is the same as than that registered in November.

The employment rate decreased by 2.8% in *Trade* and by 6.2% in *Other services*.

For the year 2020, employment registered an average decrease of 4.3 %.



Review and update of data

On the press release day, INE has updated SSAI data series corresponding to the last five months. In the case of calendar adjusted and seasonally and calendar adjusted series, according to INE standard, series are revised since its beginning. Results are available on INEBase.

Methodological note

The Services Sector Activity Indicators (SSAI) measure the short-term evolution of the activity of companies belonging to the Non-Financial Market Services sector through two variables: turnover and employed personnel. Turnover comprises the amounts invoiced by the company for provision of services and sale of goods. Employed personnel include both paid and unpaid personnel.

In order to obtain this data, an ongoing survey is conducted, every month researching more than 28,000 companies that operate in this sector. Results are presented as indices so as to measure variations as compared to the base year 2015.

The characteristics of this statistics are:

Type of survey: monthly continuous survey.

Base year: 2015.

Population scope: companies whose main economic activity is described in sections G, (Trade), H (Transport and Storage), I (Accommodation), J (Information and Communications), M (Professional, Scientific and Technical Activities) and N (Administrative and Support Services Activities) of the National Classification of Economic Activities (CNAE-09).

Geographical scope: all the national territory except for Ceuta and Melilla, for which it is only collected in division 47 of CNAE-09 (retail trade).

Sample size: 28,000 companies.

Type of sampling: stratified random sampling.

Collection method: completion of the questionnaire by the respondent using one of the following methods: internet (IRIA system), e-mail, fax, telephone or by postal mail.
