
**El coste por hora trabajada aumenta un 2,4% en tasa anual en la serie corregida de efectos de calendario y estacionalidad, y no varía en la serie original**

**Quarterly variation of the Index**

La variación trimestral del ICLA –que mide el coste laboral por hora trabajada manteniendo constante la estructura por ramas de actividad– entre el primer trimestre de 2019 y el cuarto trimestre de 2018, eliminando los efectos estacionales y de calendario, es del 0,8%.

Por componentes del coste, en datos desestacionalizados y corregidos de calendario, el coste salarial sube un 0,7% y los otros costes un 1,2%.

Sin tener en cuenta el ajuste estacional y de calendario, la tasa trimestral es del -11,1% debido, fundamentalmente, al mayor peso de las pagas extraordinarias y atrasos en el cuarto trimestre de 2018 respecto al primero de 2019.


### Annual variation of the Index

El coste por hora trabajada no varía en el primer trimestre respecto al mismo periodo del año anterior como consecuencia del mayor número de horas trabajadas debido a que la Semana Santa tuvo lugar este año en el segundo trimestre, mientras que en 2018 fue en el primero.

Si se eliminan los efectos estacionales y de calendario, la variación anual del coste por hora es del 2,4%.

## Results by activity sections

Las secciones que registran los mayores incrementos anuales en el primer trimestre son *Actividades inmobiliarias* (7,5%), *Actividades artísticas, recreativas y de entretenimiento* (3,2%) y *Administración pública y defensa; Seguridad Social obligatoria* (2,9%).

Por su parte, los mayores descensos se dan en *Actividades financieras y de seguros* (-7,4%), *Industrias extractivas* (-2,8%) y *Actividades profesionales, científicas y técnicas* (-2,4%).



Si se eliminan los efectos estacionales y de calendario, las actividades con las tasas anuales más elevadas son *Actividades inmobiliarias* (7,7%), *Actividades artísticas, recreativas y de entretenimiento* (4,8%) y *Administración pública y defensa; Seguridad Social obligatoria* (4,6%).

Por el contrario, *Industrias extractivas* (-2,3%), *Actividades financieras y de seguros* (-1,4%) y *Actividades profesionales, científicas y técnicas* (-0,5%) registran las menores tasas anuales corregidas.

#### **Results by activity sections and cost components. Original series**

Las secciones que registran los mayores incrementos anuales del *coste salarial* en el primer trimestre de 2019 son *Actividades inmobiliarias* (6,4%), *Administración pública y defensa; Seguridad Social obligatoria* (2,8%) y *Actividades artísticas, recreativas y de entretenimiento* (2,2%).

Por su parte, las variaciones más negativas se dan en *Actividades financieras y de seguros* (-8,1%), *Industrias extractivas* (-3,8%) y *Actividades profesionales, científicas y técnicas* (-3,1%).

En lo que se refiere a los *otros costes*, las secciones que registran los mayores incrementos anuales son *Actividades inmobiliarias* (11,2%), *Actividades artísticas, recreativas y de entretenimiento* (6,4%) y *Suministro de energía eléctrica, gas, vapor y aire acondicionado* (5,9%).

Por el contrario, *Actividades financieras y de seguros* (-4,5%), *Transporte y almacenamiento* (-2,3%) y *Construcción* (-2,1%) presentan los mayores descensos.

### Revision and updating of data

Coinciendo con la publicación de hoy se han actualizado los datos provisionales del ICLA del cuarto trimestre de 2018. El índice final se sitúa en 107,6 puntos.

La variación trimestral de la serie original para ese trimestre se sitúa en el 1,6%, mientras que la del índice corregido es del 0,3%. Por su parte, la tasa anual de la serie original es del 0,5% y la del índice corregido de efectos de calendario y desestacionalizado, del 1,5%. Los resultados están disponibles en INEBase.

## **Methodological note**

The Harmonised Labour Cost Index (HLCI) is a quarterly continuous statistical operation whose objective is to provide a common and comparable measure of labour cost per hour worked for the whole of the European Union, allowing the monitoring of the evolution of said labour costs.

Indices with base 2016 are provided for total labour costs, wages and salaries and other costs net of subsidies received for the use of labour factor (includes social contributions payable by employers and non-wage payments). The index for total labour cost is also provided excluding extraordinary payments and delayed payments.

Type of operation: Statistics presented mainly in the form of indices.

Base year: 2016.

Population scope: Employees in local units.

Sources of information: The Quarterly Labour Cost Survey which is conducted on the basis of the Social Security contribution accounts. General Scheme: Sections B to S of CNAE-09 and Special Scheme for Seafarers: Sea Transport (Division 50 of CNAE-09). In order to cover all employees of the general government, information from the DARETRI file is used.

Geographical scope: the entire national territory.

Reference period of the results: the calendar quarter.

Calculation method: Chained Laspeyres.
