Industrial New Orders Received Indices (INORI). Base 2005
March 2012. *Provisional data*

Main results

- The annual rate of the **Industrial Turnover Index** stands at **-6.7%** in March, almost eight points lower than that registered in February.
- By economic destination of the goods, all industrial sectors present negative interannual rates, except Energy.
- The average rate of the Industrial Turnover Index stands at **-1.6%** in the first quarter of the year.
- The annual variation rate of **New Orders Received** in the month of March is **-4.1%**, more than three-and-a-half points lower than that registered in February.
- The average rate of the General Industrial New Orders Received Index stands at **-1.7%** in the first three months of 2012.

Evolution of Industrial Turnover

The Industrial Turnover Index (ITI) experienced an interannual variation of **-6.7%** in March, almost eight points lower than that registered in February.

By economic destination of the goods, the industrial sectors that presented negative effect on the general index were:

- **Intermediate goods**, with an annual rate of **-11.9%** and an effect of **-4.521**, due to the decreases registered in almost all activities comprising this sector. Among them, worth noting, by its influence, the decreases observed in *Metallurgy; manufacture of iron, steel and ferro-alloy products* and *Manufacture of other non-metallic ore products* and *Forging, stamping, embossing and rolling of metals*. - *Manufacture of tools, hardware goods, containers and other metal products*.
- **Capital goods**, with an annual variation of **-14.7%** and an effect of **-3.454**, caused by the decrease in all the activities comprising this sector. Among them, highlighting the *Manufacture of motor vehicles, trailers and semi-trailers*.

In turn, **Energy** was the only industrial sectors that presented a positive effect on the general index, with an annual variation of 22.1% and an effect of 2.076, mainly due to the increase observed in the *Manufacture of coke and refined petroleum products*.

A more detailed analysis showed the activities that most affected the annual rate of the ITI in the month of March.



Year-to-date average rates

The average rate of the Industrial Turnover Index registered a variation of **-1.6%** in the first quarter of the year, as compared with the same period of 2011.

By economic destination of the goods, this turnover rate was positive in Energy (24.3%), and Non-durable consumer goods (2.1%). Conversely, it was negative in Intermediate goods (-6.8%), Capital goods (-7.3%), and Durable consumer goods (-10.8%).


Annual and average rates of the ITI

Evolution of the ITI, adjusted for the calendar effect

After adjusting for the calendar effect, that is, the difference between the number of working days in a given month in different years, the interannual variation of the ITI in the month of March was **-2.6%**, two tenths lower than that registered in February.

Evolution of Industrial New Orders Received

The Industrial New Orders Received Index (INORI) experienced an interannual variation of -4.1% in March, more than three-and-a-half points lower than that registered in February.

By economic destination of the goods, the industrial sectors that presented the greatest negative effects on the general index were:

- **Intermediate goods**, with a rate of -9.7% and an effect of -3.724, motivated by the decreases registered in most of the activities comprising this sector. Among them, worth noting, the observed in *Metallurgy, manufacture of iron, steel and ferro-alloy products* and the *Manufacture of other non-metallic ore products*.

- **Capital goods**, with an annual variation of -9.9% and an effect of -2.235. More than half of the activities of this sector registered decreases in new orders received, among them highlighting the *Manufacture of motor vehicles, trailers and semi-trailers*. Nonetheless, worth noting the increase in new orders received of *Naval, railway, aircraft and spacecraft construction. Combat vehicles*.

In turn, **Energy** was the only industrial sector that presented a positive effect on the general index, with an annual variation of 22.0% and an effect of 2.081, mainly due to the increase registered in the *Manufacture of coke and refined petroleum products*.

A more detailed analysis showed the activities that most affected the annual rate of the INORI in the month of March.



Year-to-date average rates

The average of the General Industrial New Orders Received Index in the first three months of the year registered a variation rate of **-1.7%**, as compared with the same period of the previous year. By economic destination of the goods, this variation rate was negative, in all of the industrial sectors, except Energy and Non-durable consumer goods.


**Annual and average rates of the INORI

After eliminating the calendar effect, that is, the difference between the number of working days in a given month in different years, the interannual variation of the INORI in the month of March was **-0.4%**, one point higher than that registered in February.
