## Annual National Accounts of Spain: Main aggregates Years 2019-2021

## In 2021, the Spanish economy fell by 5.5% in volume

# Gross Domestic Product (GDP) at current prices stood at 1,206,842 million euros

## GDP Evolution in 2021

The Spanish GDP fell in volume by 5.5% in 2021 compared to 2020 according to the flash estimates of the Annual Spanish National Accounts.

This data shows an increase of four tenths with respect to that advanced by the Quarterly National Accounts<sup>1</sup> (QNAS) on March 31. As for the growth composition, there are some variations in the estimates, with a greater contribution from domestic demand (5.2%, compared to 4.7%) and a lower contribution from external demand (0.3%, versus 0.5%).

As regards *national demand*, the year-on-year variation in the volume of *final consumption expenditure* is 5.1% compared to the 4.2% previously estimated. For its part, *gross capital formation* increased by 5.9%, compared to the previous year's estimation.

Within the *Final consumption expenditure*, the *Final consumption expenditure of households and non-profit institutions serving households* (NPISH) increased by 6.0% (compared to the 4.6% advanced in March). This upward revision was primarily a consequence of the incorporation of the results of the 2021 Household Budget Survey, published in June of this year. For its part, growth in *final consumption expenditure by Public Administrations* is now estimated at 2.9%, compared to the previous 3.1%, after incorporating the updated results of the Public Administration Accounts.

With regard to external demand, consistent with the revision of the balance of payments results, the increase in the volume of *exports* stood at 14.4%, compared to the 14.7%

estimated in March, while for *imports* it stood at 13.9%, the same figure as in the previous estimate.

At current prices, year-on-year GDP growth was 7.9%, compared with the 7.4% previously estimated. This brings the value of GDP at current prices for 2021 to 1,206,842 million euros.

The implicit GDP deflator went from 2.2% in the previous estimate to 2.3% in the current one.

Employment in terms of *full-time equivalent jobs* stood at more than 18 million. This maintains an increase of 6.6% compared with March. On the other hand, hours worked increased by 7.2%, compared to 7.0% in the previous estimate.

Finally, taking into account all the above, and the updated estimate of income flows from rest of the world, the *Gross National Income of Spain* stood at 1,213,175 million euros in 2021, or 0.2% above the previous estimate.

As a result of this update of the accounting series, GDP volume growth in 2019 was revised one tenth lower, to 2.0%. On the other hand, the variation for 2020 has been revised upwards by five tenths, to -11.3%.

The revision of results for the year 2020 is mainly due to the availability and consequent incorporation for the first time in the national accounts of the results of the structural economic surveys referring to that year (*Structural Enterprise Statistics, salary Structure Survey,* 

*Statistics on R&D activities*) that have been published throughout the second half of 2021 and the first half of 2022.

For its part, the Supply-Demand balancing process, inherent in the compilation of the 2019 *Source and Destination Tables* at current prices and at prices of the previous year, at a detailed level of 110 products, explains the revision of the series of main aggregates and of GDP in 2019.

## Methodological note

The Annual National Accounts of Spain: main aggregates is a synthesis statistic that provides the main aggregates for the national economy (*GDP*, National Income and Employment) resulting from the System of National Accounts, according to the conceptual and regulatory framework established by the European System of National and Regional Accounts (SEC 2010), approved by Regulation (EU) 549/2013, of the European Parliament and of the Council, of May 21.

In addition to measurement of the *GDP*, it also measures each of its components, prepared from the point of view of supply, demand, and income. Estimates of economic aggregates of supply and demand are presented both at current prices and in terms of volume. Employment estimates (in terms of *persons employed*, *hours worked*, *jobs* and *full-time equivalent jobs*) are also included, as well as the measurement of *gross national income* (GNI) and *gross national disposable income* (GNDI), resulting from national economic activity and income flows with the rest of the world.

The National Accounts is constructed from estimates of economic flows and aggregates that are sourced from a wide variety of statistical operations, which in turn are subject to their own schedule of availability and review. This means that the estimates of the macroeconomic aggregates are subject to a review process and, also, to gradual disaggregation, until they become definitive.

This operation is thus disseminated in September of year t, and it offers an *advance estimate* for year t-1, a *provisional estimate* for year t-2 and a *final estimate* for year t-3.

At least every five years, extraordinary reviews of the complete results series must be carried out to guarantee the updating of statistical sources and estimation methods, as well as their alignment with the recommendations released by the relevant international forums. The most recent of these reviews was published in September 2019.

However, on this occasion - in addition to the revisions that are part of the usual policy - those derived from the change in the timing of the reclassification of SAREB in the Public Administration Sector will be included. Thus, in March 2022, Eurostat communicated its agreement with the decision of the Spanish statistical authorities to reclassify the SAREB in that sector since the beginning of its activity (in 2012).<sup>2</sup>

All national accounts results published from today onwards shall be consistent with the main aggregates of the national economy published now, according to the established calendar.

Thus, on September 23rd, the results of the *Quarterly National Accounts of Spain: main aggregates,* shall be published, through the second quarter of 2021.

On the other hand, on September 30, the results for the 2019-2021 series of the Annual National Accounts of Spain: aggregates by activity branch, of the Annual Non-Financial Accounts of the Institutional Sectors and of the Quarterly Non-Financial Accounts of the Institutional Sectors will be published through the second quarter of 2021.

The Origin and Destination Tables for the year 2019, both at current prices and at prices of the previous year, will also be published on September 30.

This dissemination calendar is in line with the deadlines stipulated in the Data Transmission Program to Eurostat established by ESA 2010.
