#### Structural Enterprise Statistics: Trade Sector Year 2019. Definitive Results

### Turnover in the Trade sector increased by 4.1% in 2019 and stood at 782,064 million euros

### Retail trade accounted for 31.4% of the total turnover in the sector and for 54.5% of the employed personnel

Turnover of companies in the Trade sector<sup>1</sup> reached 782,064 million euros in 2019, which represented an increase of 4.1% as compared with the previous year.

The gross value added generated by emterprises in this sector stood at 116,892 million euros, 4.9% more than the previous year.

#### Results by divisions of activity<sup>3</sup>

The activity *Wholesale trade, except of motor vehicles and motorcycles* invoiced 442,427 million euros, which represented 56.6% of the sector and 5.2% more than in 2018. Wholesale companies employed 35.4% of the total personnel.

*Retail trade, except of motor vehicles and motorcycles* accounted for 31.4% of the total turnover for the sector and for 54.5% of employed personnel. Turnover in the retail trade sector increased by 2.4%.

On the other hand, turnover in *Wholesale and retail trade and repair of motor vehicles and motorcycles* increased by 3.6%.

#### Results by groups of activity

At a more disaggregated level, the activity groups with the highest contribution to total turnover were *Wholesale of food, beverages and tobacco* (17.3% of the total), *Wholesale of household goods* (13.7%) and *Other specialised wholesale*<sup>4</sup> (13.4%).

The groups of activity that employed the greatest number of people were *Retail sale in non-specialised stores* (17.3% of employment in the sector), *Retail sale of other goods in specialised stores* (15.2%) and *Wholesale of food, beverages and tobacco* (11.7%).

<sup>&</sup>lt;sup>4</sup> Other specialised wholesale trade includes wholesale trade of solid, liquid and gaseous fuels and related products, metals and metal ores, wood, construction materials and sanitary equipment, hardware, plumbing and heating equipment and supplies, chemical products, other intermediate products, scrap and waste.

On the other hand, the groups that increased their turnover the most compared to the previous year were *Wholesale of agricultural raw materials and live animals* (12.1%), *Retail trade not in stores, stalls or markets*<sup>5</sup> (11.9%) and *Wholesale of information and communication equipment* (8.9%).

#### Productivity



Productivity (value added per employed person) for the Trade sector was 36,287 euros in 2019, 2.7% more than in the previous year.

The activity groups with the highest productivity were *Wholesale* of *information* and *communication* equipment (62,845 euros), *Wholesale* of *household* goods (62,276 euros) and *Wholesale* of other machinery, equipment and supplies (59,136 euros).

In turn, the least productive activities were *Retail sale via stalls and markets* (9,250 euros), *Retail sale of food, beverages and tobacco in specialised stores* (18,163 euros) and *Retail sale of other household equipment in specialised stores* (22,654 euros).

#### Geographical destination of sales



In 2019, 88.5% of sales in the Trade sector were within Spain, 7.7% went to other European Union countries, and 3.8% to the rest of the world.

The activity groups with the highest percentage of sales outside of Spain were *Non-specialised wholesale trade* (27.0% of total sales), *Retail trade not in establishments, stalls or markets* (20, 4%) and Wholesale of food, beverages and tobacco (19.6%).

#### **Investment in Tangible Assets**

Investment in tangible assets carried out by the Trade sector amounted to 11,053 million euros in 2019. 45.3% came from *Retail trade, except for motor vehicles and motorcycles* and 43.7% from *Wholesale and trade intermediaries, except for motor vehicles and motorcycles*.

As for added value, investment in tangible assets accounted for 10.4% for companies in the activity of *Retail trade, except of motor vehicles and motorcycles* and 10.0% of the added value for the companies of *Sale and repair of motor vehicles and motorcycles*.

#### Investment in tangible assets by divisions of activity. Year 2019


#### Results by size of the enterprise

Press Release

Trade is characterised by the predominance of very small enterprises. In 2019, 95.1% of the companies in the sector had less than 10 employees. These enterprises provided employment for 41.9% of personnel and their turnover represented 25.6% of the total.


In turn, large enterprises (with 250 or more employees) represented 0.1% of Trade enterprises, and their turnover accounted for 34.6% of the total in the sector. These enterprises employed 28.8% of the personnel.

#### Size of the enterprises and productivity

Medium-sized enterprises (of 50 to 249 employees) had the highest productivity in 2019, with 52,795 euros. In turn, enterprises with less than 2 employees were the least productive, with 18,283 euros.

#### Results by Autonomous Communities<sup>6</sup>

The Autonomous Communities with the greatest participation in turnover for the Trade sector in the year 2019 were Comunidad de Madrid (with 25.1% of the total), Cataluña (19.5%) and Andalucía (12.5%).

In turn, those with the least weight were La Rioja (0.5%), Cantabria (0.8%) and Extremadura (1.3%).

The Autonomous Communities that most increased their turnover compared to the previous year were Andalucía and Comunidad Foral de Navarra (both with 6.7%) and Comunitat Valenciana (6.1%).

<sup>&</sup>lt;sup>6</sup>To obtain the results by Autonomous Community, the Local Unit whose main activity is Trade is considered a statistical unit. These local units may be part of Enterprises whose activity is included in other sectors and, in this case, their data at the Enterprise level is not included in the Trade sector. Another difference between this regional data (by premises) and the national data (by enterprises) is that only in the latter is it necessary to apply internal flow consolidations to each enterprise. This explains why the total turnover is somewhat higher in regional data than in national data.

### Methodological note

The SES: Trade Sector is an annual structural statistical operation aimed at companies engaged in Trade, which includes wholesale and retail trade and repair of motor vehicles and motorcycles, wholesale trade and commission trade, and retail trade.

This operation, governed by Regulation 295/2008 of the Parliament and of the Council of the European Union, allows us to ascertain the main structural and economic characteristics of companies in the sector under study by means of a broad set of variables relating to employed personnel, turnover and other income, purchases and consumption, personnel expenses, taxes and investments. The statistic includes economic aggregates such as the value of production and gross value added, as well as main indicators.

Type of survey: annual continuous operation.

**Population scope:** companies whose main activity is described in section G of CNAE-2009, which includes the sale and repair of motor vehicles and motorcycles, wholesale trade and commission trade and retail trade.

Geographical scope: the entire national territory.

**Reference period:** the calendar year, which, with some exceptions, coincides with the company's accounting year.

**Sample size:** 60,697 units (66% with direct collection and 34% with administrative data).

**Collection method:** completion of the questionnaire by the respondent, mainly via the Internet (IRIA system), and use of administrative sources.

### Annex

### Structure and evolution in the Industry, Trade and Services sectors

The combined turnover of the *Industry*, *Trade* and *Non-financial Market Services* sectors exceeded 2,029 billion euros in 2019. Turnover in the Services sector increased by 6.7%, that of Commerce by 4.1% and that of the Industrial Sector by 1.6%.

The industrial sector accounted for 33.6% of this turnover and employed 18.7% of the personnel. *Trade* invoiced 38.5% of the total, although its gross value added represented 21.8%. On the other hand, the *Services* sector accounted for 27.9% of turnover, 48.2% of the value added and employed 55.2% of the personnel of the three sectors.
