Statistics on Domestic Violence and Gender Violence (SDVGV) Year 2020

The number of women who were victims of gender violence decreased by 8.4% in 2020, up to 29,215

The rate of victims of gender violence was 1.4 per 1,000 women aged 14 years old and over

The number of domestic violence victims increased by 8.2%

Cases initiated

This section provides information about victims and persons with protection orders or courtordered interim measures recorded in the reference year in the Central Register for the Protection of Victims of Domestic and Gender Violence.¹

The total persons recorded as victims of gender or domestic violence in 2020 reached 37,819, 4.9% less than in 2019. Of these, 34,446 were women and 3,373 men.

Gender violence



Gender Violence is understood as any physical or psychological act of violence (including attacks on sexual freedom, threats, coercion or arbitrary deprivation of freedom) carried out against a woman by a man who is or has been her spouse, or who is or has been linked to her by a similar sentimental relationship, even if without cohabitation.

Victims of gender violence

In 2020, 29,215 women victims of gender violence were registered, in cases in which interim measures or protective orders had been issued, indicating a 8.4% decrease as compared with the previous year.

We should note that the greatest decreases in the number of female victims of gender violence were registered in the months in which mobility was restricted by the pandemic.

Almost half of the victims of gendered violence (48.3%) were aged 30 to 44. The average age of the victims was 37.1 years old.

The greatest decrease in the number of victims in 2020 was among women under 18 years of age (-28.5%). In turn, the greatest increase was observed in women from 50 to 54 years of age (3.1%).



The rate of victims² was 1.4 per 1,000 women aged 14 years old and over. The highest values were reached in the age groups 30 to 34 years (3.4 victims per 1,000 women) and 25 to 29 years (3.1).

Regarding place of birth³, nearly two out of every three victims of gendered violence were born in Spain (62.9% of the total), a similar proportion as last year.



The victim rate per 1,000 women aged 14 and older was almost three times higher among women born abroad (3.1) than that among women born in Spain (1.0). In both cases the figures are similar to last year.

Among foreign-born victims, those from Africa and the Americas had the highest rates. Those of Asia and Oceania had the lowest.

Results by Autonomous Communities and Cities

Release

Press

The Autonomous Communities with the highest number of registered victims of gender violence in 2020 were Andalucía (6,813), Comunitat Valenciana (4,473) and Comunidad de Madrid (3,149).

In turn, the Autonomous Cities of Ceuta and Melilla, and La Rioja showed the lowest rates of victims.

The largest annual increases in the number of victims occurred in the autonomous cities of Melilla y Ceuta (7.1% and 5.1%, respectively). Conversely, the greatest decreases were registered in País Vasco (-21.9%) y Aragón (-17.4%).



In relative terms, the highest rates of registered victims of gender violence per 1,000 women aged 14 and older were recorded in the Autonomous Cities of Melilla (2.3), Región de Murcia (2.1) and La Rioja y Comunitat Valenciana (2.0 in both).

In turn, País Vasco (0.6), Cataluña (0.8) and Galicia (0.9) presented the lowest rates.

Release

A total of 29,135 men were reported on gender violence in cases with protective orders or interim measures issued and recorded in the Register throughout the year 2020, which was 8.4% less, compared to the previous year.

Almost half of the persons reported (48.3%) were aged 30 to 44 years old. The average age of persons reported was 39.9 years old.

The greatest decreases in the number of persons reported for gender violence occurred among those under 18 years of age (-42.4%), and in the group aged 18 to 19 years of age (-21.6%).



The rate of those reported for gender violence⁴ was 1.5 per 1,000 men aged 14 years old and over. The rate reached its peak in the groups 30 to 34 years (3.2 reported for every 1,000 men of said age) and 35 to 39 years (3.0).



The rate of persons reported per 1,000 men aged 14 years old and above was greater among those born abroad (3.3) than among those born in Spain (1.1).

Within those born abroad, the highest rates of reported persons corresponded to those born in Africa and America. The lowest rates were recorded among those born in Asia and Oceania.

Relations of the victims with the persons denounced

Insofar as the type of relationship between the victim and the accused, in 25.2% of cases the victims were spouses or former spouses; in 44.4% they were or had been in a civil union; 29.4% was a girlfriend or a former girlfriend; and 1.1% were in the process of separation.



In three out of every four couples (73.9%) the reported person and the victim were between 20 and 49 years old.

By place of birth, 53.5% of the couples were born both in Spain, 10.3% in America, and in 6.2% of cases the person reported was born in Spain and the victim in America.

Criminal offences and interim measures of gender violence

Release

In 2020, 34,369 criminal offences⁵ were recorded, charged to persons reported for cases of gender violence registered during that year, 10.4% less than in 2019.

The average number of criminal offences per person reported was 1.2, the same as in the previous five years.

The most frequent criminal offences were those relating to *Injuries* (51.8% of the total), *Torture* and other crimes against moral integrity (20.2%) and *Threats* (15.2%).

The total interim measures ordered⁶ and recorded in the Register for cases of gender violence in 2020 reached 90,912; that is, 8.2% less than in the previous year.

Considering the nature of the measures, 73.7% were of a criminal nature and 26.3% of a civil nature.

The most frequent criminal interim measures were the *prohibition of approaching given persons* (37.4% of the total), the *prohibition of communicating with given persons* (36.5%) and *conditional release* (13.4%).

Among the civil interim measures, the most frequent were the *determination of the alimony regime* (27.2% of the total), *the determination of custody rights* (26.5%) and the *determination of the visitation regime* (23.3%).

Domestic violence

Domestic Violence is understood as any physical or psychological violence carried out by a man or a woman, on any of the persons listed in article 173.2 of the Criminal Code (descendants, ancestors, spouses, siblings, etc.) with the exception of specific cases of gender violence.

Victims of domestic violence

In 2020, 8,279 victims of domestic violence holding interim measures or protective orders were registered, representing 8.2% more than in the previous year. Among them, 61.4% were women, and 38.6% of them were men.

The total number of victims of domestic violence was greater than the number of persons reported, with a rate of 1.5 victims for each person reported.


Moreover, a total of 325 persons appeared as both reported persons and victims at the same time.

Unlike gendered violence, domestic violence affected all age groups more uniformly. Among them, it is worth noting the under 18 age group, with almost one in four victims (26.0% of the total).

The average age of the victims was 41.4 years old.

In relative terms⁷, in matters of domestic violence, the rate of female victims was 0.21 per 1,000 women and the rate of male victims, 0.14 per 1,000 men.

The most frequent casualty rates were among those under 18 years of age, both in women (0.30) and in men (0.22).

Victims of domestic violence by sex and place of birth. Absolute values and variation rates (%)



In relative terms, issues of domestic violence had a similar rate among foreign and Spanish men (both 0.14 per 1,000 inhabitants).

In the case of female victims, those born abroad presented a higher rate than those born in Spain (0.25 compared to 0.20).

The highest rates of victimhood were from Africa for women (0.44) and the Americas for men (0.17).

By Autonomous Community, those that registered the highest number of registered victims of domestic violence in 2020 were Andalucía (1,801), Comunitat Valenciana (1,138) and Cataluña (960). In turn, the Autonomous Cities of Melilla (24) and Ceuta (48), and Cantabria (60) showed the lowest rates of victims registered.

The greatest increases in the number of victims were registered in the Autonomous City of Melilla (380.0%), the Autonomous City of Ceuta (166.7%) and Aragón (22.1%).

In turn, the greatest decreases were in Principado de Asturias (-9.6%), La Rioja (-7.3%) and Comunidad Foral de Navarra (-6.2%).

As for the rates per 1,000 inhabitants of registered victims of domestic violence, the highest rates in the case of men were recorded in the Autonomous City of Ceuta (0.54), La Rioja (0.22) and Región de Murcia and the Autonomous City of Melilla (0.19 in both cases).

In the case of females, the highest rates were registered in the Autonomous City of Ceuta (0.60) and Melilla (0.38) and in La Rioja (0.34).

Persons reported for domestic violence

Press Release

In 2020, a total of 5,578 persons were reported for domestic violence, 3.4% more than in the previous year. Among them, 72.2% were men and 27.8% were women.


As with last year, there was an increase in both the percentage of men reported (3.7%) and women reported (2.6%).

By age, half of the persons reported were between 30 and 49 years of age (51.5%). The average age of persons reported was 36.6 years old.



Relationship of the victims with the persons reported

In terms of the type of relationship existing between the victim and the reported person, in 38.4% of cases the victims were the father or mother, in 29.2% the children, and in 9.9% the victim was a sibling.

According to place of birth, in 74.8% of the cases both the victim and the reported person were born in Spain, in 5.8% they were both born in America, and in 4.6% the reported person was born in America and the victim in Spain.

Criminal offences and interim measures of domestic violence

The number of criminal offences⁸ charged to persons reported for domestic violence in 2020 rose to 6,739; 5.4% more than in the previous year. The number of criminal offences per person reported was 1.2.

The most frequent criminal offenses were those related to *Injuries* (49.5% of the total), *Threats* (18.9%) and *Torture and other crimes against moral integrity* (17.8%).

During 2020, 13,302 interim measures⁹ were ordered in registered domestic violence cases, representing an increase of 7.4% as compared with the previous year. Of these measures, 72.6% were handed down to men, and 27.4% to women.

Considering the nature of the measures, 94.4% were criminal interim measures, and 5.6% civil interim measures.

The most frequent criminal interim measures were the *prohibition of approaching given persons* (38.4% of the total), the *prohibition of communicating with given persons* (34.2%) and *conditional release* (13.3%).

In turn, the most common civil interim measures were the *determination of custody rights* (27.6% of the total), the *determination of child support* (18.7%) and the *determination of visiting rights* (16.5%).

Final judgements

Press

This section provides information relating to final judgements in 2020 of persons convicted and acquitted corresponding to cases (with protective orders and interim measures issued) registered in the Central Register for the Protection of Victims of Domestic and Gender Violence in 2020 or in previous years.

This is oriented to the study of the final stage of the criminal process (proceedings in final judgement) which results in final convictions (sentences and security measures) that fall on the convicted person. Moreover, it provides results on final acquittals (persons acquitted).

In 2020, 30,616 persons convicted of gender and domestic violence were registered in the Register, 14.8% less than in 2019. Among them, 28,568 were men and 2,048 were women.

In turn, there were 4,204 persons acquitted, 27.7% less than in 2019, of which 3,835 were men and 369 were women.

Duration of the cases¹⁰

With respect to cases of gender violence, seven out of ten persons (71.1%) received final judgement in less than one year. On the other hand, 16.1% of the persons received final judgement between one and two years, 7.5% between two and three years and 5.3% in three years or more.

With respect to cases of domestic violence, 67.7% of the persons received final judgement within a year, 18.8% between one and two years, 7.5% between two and three years and 5.9% in three years or more.

Review and update of data

Methodological note

The Statistics on Domestic Violence and Gender Violence are obtained from the statistical use of the Central Register for the Protection of Victims of Domestic and Gender Violence. These statistics are compiled by the INE by virtue of a collaboration agreement signed with the Ministry of Justice, the body responsible for this register, which was signed by both institutions on 3 July 2007 and updated and renewed on 21 November 2017.

The information on gender violence and domestic violence is presented separately. The results refer to the cases initiated, with interim measures ordered, recorded in the register during the reference year. As of 2015 information is also published concerning final judgements handed down in the reference year, which correspond to cases that were recorded in the register in that year or in previous years.

The objective of this statistics is to determine the number of victims holding protective orders and interim measures and the number of persons reported in cases recorded in the register during the reference year. Since 2015, persons convicted and acquitted in final judgements handed down in the reference year are included, corresponding to cases recorded in the register in the reference year or in previous years. This allows for study of the main sociodemographic characteristics (sex, age, place of birth, type of relationship) and for detailed information to be provided on the precautionary measures ordered, the criminal offences charged, and the penalties imposed, both at the national and regional levels.

Type of operation: annual continuous statistical operation.

Population scope:

Cases Initiated: Group of persons reported aged 14 years old and over and the victims corresponding to cases with interim measures ordered, registered in the Central Register for the Protection of Victims of Domestic and Gender Violence during the reference period. **Final Judgements:** Group of persons acquitted and convicted through final judgement, corresponding to matters in which precautionary measures were pronounced, registered in the Central Registry for the Protection of Victims of Domestic and Gender Violence during the reference period.

Geographical scope: the entire national territory.

Reference period for the results: the calendar year.

Reference period of the information: dates of initiation of the case and dates of the final judgement.

Collection method: statistical use of an administrative register.
