Indicators of the Information and Communication Technology Sector (ICT) Year 2019

Main results

- Turnover of companies in the ITC sector reached 108,047.7 million euros in 2019, with an increase of 6.4%, as compared to the previous year.
- The number of companies in the ICT sector that carried out R&D stood at 1.778, indicating a 3.3% increase.
- The trade deficit of companies in the ITC sector increased by 8.3%. The largest import volume for ITC products was telecommunications and computer equipment.

Main variables in the ICT sector

Turnover for companies in the Information and Communication Technologies (ICT) sector stood at 108,047.7 million euros in the year 2019, which is, an increase of 6.4% with respect to the previous year. These companies generated a value added of 38,902.3 million euros.

The number of companies in the ICT sector stood at 69.524, indicating a increase of 0.6%. In turn, the number of persons employed grew by 5.7%, standing at 527.731 persons.

Wage costs in the ICT sector

The wage cost per worker in the ICT sector stood at 2,596.7 euros per month in the fourth quarter of 2019. The wage cost of the *Manufacturing industry* was 2,766.5 euros and that of *ICT Services* was 2,593.5 euros.

As for the hourly wage cost, the highest wages were recorded in *Telecommunications* (24.4 euros), *Programming, consulting and other activities related to computer science* (22.3 euros) and *Publishing* (20.3 euros).

Companies in the ICT sector which carried out R&D activities

The number of companies in the ICT sector that carried out R&D activities in 2019 increased by 3.3%. This translated to 1.778 companies, or 16.0% of all businesses carrying out this type of activity.

Employed personnel (in full-time equivalence) decreased by 1.5%. The number of female researchers fell by 17.7% and that of researchers in general by 8.2%.



Companies in the ICT sector that carried out e-commerce

In 2019, 65.2% of the companies in the ICT sector with 10 or more employees made purchases through e-commerce as compared to 34.9% of the total of the business sector.

On the other hand, 22.6% made sales through e-commerce, compared to 25.5% of businesses overall.



Companies involved in e-commerce (2018 – 2019).

Companies in the ICT sector made e-commerce sales amounting to 14,705.1 million euros, which represented 4.8% of total e-commerce sales.

As for purchases, companies in the ICT sector spent 11,274.3 million on e-commerce, or 4.3% of total purchases.

Production value of ICT goods

According to the Industrial Products Survey, the production value of ICT goods was 3,151.1 million euros in 2019, with a growth of 3.9% compared to the previous year.

By product group, Audio and Video Equipment recorded the highest increase (12.7%).

The production value of ICT goods accounted for 0.7% of the total value of the industrial production in 2019.

Foreign trade of ICT products

ICT products had a negative trade balance of 13,819.7 million euros in 2019, with an 0.7% increase in the trade deficit compared to the previous year.

Total exports reached 5,870.8 million euros, while imports reached 19,690.6 million euros.



The exports of the ICT sector represented 2.0% of the Spanish exports in 2019, equal to 2018. On the other hand, imports represented 6.1% of national imports, compared to 6.0% the previous year.

Methodological note

The **Information and Communications Technologies (ICT) Sector Indicators** seek to describe the situation of the sector on the supply side rather than the use side, with the aim of providing relevant information on manufacturing and service industries whose main activity is linked to the development, production, commercialisation and intensive use of Information and Communications Technologies. These sectors are characterised by high rates of innovation, technological progress and productivity, and therefore they have a substantial impact on economic activity.

In order to develop the indicators, information from other statistical operations is collected. Tables with overall values of the ICT sector are published with the following variables: turnover, production value, added value, employed persons and other variables specific to the sector (classification variables, branch of activity and type of product), exports and imports.

Type of survey: annual synthesis statistics.

Population scope: National companies whose main activity (manufacturing, commercial or services) corresponds to the ICT field.

Geographical scope: the entire national territory.

Reference period: the calendar year.

Collection method: synthesis of different statistical operations.
