
# The Tourism and travel balance improves

According to provisional data from the Bank of Spain, in 2022, the balance of the current and capital accounts, which determines the nation's lending or borrowing capacity, had a surplus of 25.0 billion euros, higher than the 22.4 billion euros accrued in December 2021. The Tourism balance increased 30.7 billion euros.

## Positive and increasing balances in 2021

The current and capital account balance, which includes income and payments for exports and imports of goods and services and for primary and secondary income, amounts to 1.9% of GDP in 2021.

### Balance of current and capital accounts (% GDP)



# The commercial deficit increases

Spanish exports of goods increased by 22.9% during 2022 and reached a total of 389,208.9 million euros. On the other hand, imports have also increased and amounted to 457,321.2 million euros (33.4% more). As a result, the trade balance recorded a deficit of 68,112.2 million euros versus 26,177.9 million euros in the same period of 2021.

> A total of 62.8% of exports of goods have the EU as destination and 44.7% of imports come from EU member states.
