

Industry turnover by geographical destination of sales. 2020




In 2020, the Industrial Sector lost companies, employed persons and turnover


The turnover of enterprises in the industrial sector, according to the Structural Enterprises Statistics: Industrial Sector, stands at 604,088 million euros in 2020, 11.3% less than in 2019.

In 2020, the manufacturing industry accounted for 82.3% of turnover, and the turnover for this activity registered a decrease of 11.4%, as compared with the previous year.

In terms of employment, the Industry employs 2.3 million people, with a decrease of 0.8% when compared to 2019.



The pharmaceutical industry increased its turnover by 5.6%

The activity branches with the greatest contribution to the *industrial turnover* were Manufacture of food products (with 18.1% of the total), *Electric power* generation, transmission and distribution (11.1%), and Manufacture of motor vehicles, trailers and semi-trailers (10.7%).

The only activity branches where turnover increased in 2020 were the *Manufacture of pharmaceutical products* (5.6%) and *Sanitation, waste management and remediation activities* (0.6%).

The tobacco industry recorded the highest productivity

Productivity (added value per employed person) of the *Manufacturing industry* was 55,938 euros on average. The highest is recorded in the *Tobacco industry* oven products and the lowest in *Manufacture of wearing apparel*.





A total of 84.0% of industrial companies had less than 10 employees

The Autonomous Communities with the greatest contribution to industrial turnover in the year 2020 were Cataluña (22.1% of the total), Comunidad de Madrid (11.1%) and Andalucía (11.0%).

A total of 84.0% of industrial companies had less than 10 employees in 2020, and 12.8% have between 10 and 49 employees. Overall, these companies are an employment source for 37.9% of sector personnel and their turnover accounts for 19.8% of the total.

Vehicles and pig-fodder the heaviest players in national production sales

According to the Industrial Products Survey, the value of national manufacturing industry product sales reached 456,635 million euros in 2021. Among the manufactured products with the highest sales figures in 2021 are gasoline vehicles with a cylinder capacity less than or equal to 1,500 cm³ (intended to transport less than 10 people), food manufactured as pigfodder, and diesel vehicles with a cylinder capacity of between 1,500 and 2,500 cm³, intended for the transport of less than 10 people.
